There are two options for payment: Pay in Full (PIF) or Payment Plans. If choosing a payment plan, a \$500 deposit will hold your place. You will receive an invoice to pay 50% of the remaining balance on December 1, 2026 and February 1, 2027. Invoices are due upon receipt.

Airport Information

When planning your flight to Ouzarzate (OZZ), consider connecting through Paris Orly Airport (ORY). You can also fly to Casablanca (CMN) a day early, spend the long layover enjoying the city, and then take a smaller in-country flight to Ouzarzate (OZZ). Book your flight as a multi-city trip or in two single-leg trips. You will be flying home from Marrakesh (RAK) so you won't need a round trip ticket.

Travel Insurance

Because there are no refunds for this retreat for any reason, and because unexpected events can occur at any time, we strongly recommend purchasing travel insurance at the time of booking.

Travel insurance is beneficial in situations such as:

- Medical emergencies (U.S. health insurance typically does not cover care outside the country)
- Emergency evacuation or transport back to the U.S. due to medical issues, political unrest, or a pandemic
- Lost or delayed luggage
- Theft at your destination
- Illness prior to departure preventing you from traveling
- Illness of a family member or pet requiring you to return home
- Other unexpected disruptions

If you do not intend to purchase traveler's insurance for your trip, please check that choice on our checkout form. Your acknowledgement indicates that:

"I was offered the option to purchase travel cancellation / protection insurance and have declined. I understand the risks associated with being an uninsured traveler and am willing to assume those risks. I will not hold Whole Image Wellness or Go Farther Travel responsible for any expenses incurred for which I have no recourse to recoup. I have read and understood all contracts, terms, and conditions, and I acknowledge that any financial obligations within these documents will be my responsibility as specified."

Cancellation Policy

Because significant time and financial investment is required to plan the retreat and secure lodging, no refunds can be issued under any circumstances. This includes, but is not limited to, personal injuries, medical emergencies, illness, natural disasters, political events, weather, or any other unforeseen situation.

- All payments are non-refundable but are transferable.
If you are unable to attend, it is your responsibility to find someone to take your spot.
- Travel insurance is highly recommended at the time of booking or paying in full.
- If Whole Image Wellness must cancel the retreat, all payments received will be refunded in full.

Whole Image Wellness is not responsible for any expenses incurred in preparation for the retreat, including airfare, travel delays, flight cancellations, car rentals, or loss of work, even if the retreat is canceled by the hosting retreat company or retreat center. No refunds or credits will be provided for late arrivals, early departures, unused services, or voluntary withdrawal after the Retreat has begun.

Itinerary Flexibility & Unexpected Circumstances

Whole Image Wellness, Inc. is committed to delivering the Retreat substantially as described in the attached itinerary. At the same time, international travel—particularly travel in remote regions of Morocco—may occasionally require adjustments due to weather, local conditions, safety considerations, government actions, transportation disruptions, or other circumstances beyond our reasonable control.

Any additional expenses resulting directly from a Force Majeure Event, including airfare changes, additional accommodations, meals, transportation, or other travel-related costs, remain the responsibility of the individual incurring those expenses.

No refunds will be issued for any vendor, hotel, or activity provider who cancels or alters any portion of the retreat, as many of these reservations are prepaid and nonrefundable. If a vendor or provider cancels an activity or service, we will make every reasonable effort to provide a comparable replacement, but this cannot be guaranteed.

If Whole Image Wellness receives refunds, credits, or reimbursements from its independent third-party suppliers as a result of a Force Majeure Event, those amounts will be passed through to the affected participant after deduction of any non-recoverable costs already incurred by the Company.

Animal Safety

Animals are an important part of many experiences in Morocco, including camel trekking and other cultural activities. While the tour company works with experienced handlers and reputable local providers, animals are inherently unpredictable and may react unexpectedly.

These guidelines exist to protect both the animals and the guests and reflect standard practice for animal encounters anywhere in the world. With that in mind, the participant agrees to:

- Follow all reasonable instructions provided by handlers, guides, and Company representatives when interacting with animals;
- Not approach, feed, touch, or attempt to handle any animal unless specifically instructed to do so by an authorized handler or guide; and
- Not place hands, food, or personal belongings near any animal's mouth, and maintain an appropriate distance from animals unless directed otherwise.

Unauthorized interaction with domestic or wild animals is strongly discouraged. Failure to follow reasonable safety instructions regarding animals may increase the risk of injury, and Whole Image Wellness is not responsible for injuries or losses resulting from a participant's failure to follow those instructions.

Ostriches and other wild animals can be dangerous at times and should not be approached.

Health Agreement

By registering for this retreat, you affirm that you have no physical, mental, or medical conditions that would adversely affect your ability to stay on the retreat or participate in the yoga program and other physical or cultural activities. You acknowledge that some activities may be mentally or physically challenging and agree to communicate privately with Angelique if you are unable or unwilling to participate.

By attending this retreat with Angelique Flynn, you knowingly and freely assume all risks related to illness and infectious diseases, including COVID-19, even if arising from the negligence or fault of the Released Parties.

The Retreat Guest understands that emergency medical facilities in remote areas may be limited and acknowledges the importance of maintaining appropriate travel insurance that includes emergency medical treatment and evacuation coverage.

Code of Conduct

Whole Image Wellness is committed to creating an environment where participants, local communities, guides, and staff are treated with dignity, kindness, and mutual respect.

The Retreat Guest agrees to:

- Treat fellow participants, guides, drivers, hosts, and local communities with courtesy and respect.
- Follow applicable local laws and cultural expectations, including those relating to photography, religious sites, dress, and appropriate conduct.
- Respect accommodations, transportation, equipment, and property belonging to local partners.
- Follow reasonable instructions provided by Company representatives, guides, and local hosts when necessary for safety or the smooth operation of the Retreat.

If a participant's conduct presents a significant safety concern or materially interferes with the enjoyment of the Retreat by others, the tour company reserves the right to remove that individual from the Retreat when reasonably necessary. Any decision to remove a participant will be made thoughtfully, in good faith, and with consideration for the circumstances. Removal from the Retreat does not entitle the participant to a refund.

Limitation of Liability

The fulfillment of this agreement is subject to acts of God, war, government regulation, natural disasters, hurricanes, floods, terrorist attacks, strikes, civil disorder, and curtailment of required transportation or other emergencies that make travel inadvisable, illegal, or impossible. If such events occur, this agreement may be terminated by written notice from one party to the other without liability.

General Waiver of Liability

By choosing to participate in the retreat's yoga classes, poses, sequences, or related activities, the Participant acknowledges the inherent risks and agrees to participate at their own risk.

The Participant fully and forever releases and discharges Angelique Flynn, Whole Image Wellness, Inc., and all teachers and staff from any and all claims, liabilities, losses, expenses,

attorney's fees, demands, actions, or causes of action—known or unknown—arising from participation in any class or activity.

Yoga is not a substitute for medical attention, diagnosis, or treatment and may not be safe under certain medical conditions. You acknowledge that you are solely responsible for determining whether to participate. You agree to irrevocably release and waive any claims now or in the future against Angelique Flynn, Whole Image Wellness, Inc., and all staff.

Media Release

The Participant grants Whole Image Wellness, Inc. permission to photograph, videotape, and/or digitally record their likeness and to use such images or recordings in any public media including radio, television, internet, social media, print, or organizational publications. These materials may be used for advertising, marketing, fundraising, promotional, or public awareness purposes.

The Participant waives all rights to inspect, approve, or receive compensation for the use of such images or recordings and releases the organization and all affiliated persons from any related claims or liabilities.

If the Participant does not wish to appear in public media, they agree to excuse themselves from group photos and videos. They understand that they may not request selective removal or editing of images. The Participant must discuss concerns with Angelique prior to the trip and agrees not to infringe upon the ability to photograph other participants.
